23 These dates are set at the direction of the Court after reviewing the joint
 24 status report and discovery plan submitted by the parties. All other dates are
 25 specified in the Local Rules. If any of the dates identified in this order or
 26 the Local Rules fall on a weekend or federal holiday, the act or event shall be
 performed on the next business day. These are firm dates that can be changed
 only by order of the court, not by agreement of counsel or the parties. The
 court will alter these dates only upon good cause shown: failure to complete
 discovery within the time allowed is not recognized as good cause.

If the Markman hearing or trial dates assigned to this matter create an
 irreconcilable conflict, counsel must notify Ashleigh Drecktrah, Deputy Clerk,
 at (206) 370-8520 within 10 days of the date of this order and must set forth
 the exact nature of the conflict. A failure to do so will be deemed a waiver.

The parties shall comply with the procedures outlined in the court's
Standing Order as to all patent claim construction issues. PLEASE NOTE:
 The court will not rule on dispositive motions that raise issues of claim

1 construction prior to the hearing, unless special circumstances warrant
2 and leave of court is obtained in advance of filing.

3 As required by Local Rules W.D. Wash LCR 37(a), all discovery matters
4 are to be resolved by agreement if possible. In addition, pursuant to
5 Federal Rule of Civil Procedure 16, the Court "direct[s] that before
6 moving for an order relating to discovery, the movant must request a
7 conference with the court" by notifying Ashleigh Drecktrah at
8 (206) 370-8520. See Fed. Rule Civ.P. 16(b)(3)(B)(v). Counsel are further
9 directed to cooperate in preparing the Joint Claim Chart and final pretrial
10 order in the format required by LCR 16.1, except as ordered below.

11 The original and one copy of any exhibits to be used at the Markman
12 hearing and/or trial are to be delivered to chambers five days before the
13 trial date. Each exhibit shall be clearly marked. Exhibit tags are available
14 at the Clerk's Office. The Court hereby alters the LCR 16.1 procedure for
15 numbering exhibits: Plaintiff's exhibits shall be numbered beginning with
16 1. Defendant's exhibits shall be numbered consecutively beginning with
17 500. Duplicate documents shall not be listed twice; once a party has
18 identified an exhibit in the pretrial order, any party may use it. Each
19 set of exhibits shall be submitted in a three-ring binder with
20 appropriately numbered tabs.

21 Counsel must be prepared to begin trial on the date scheduled, but it
22 should be understood that the trial may have to await the completion of
23 other cases.
