**JOINT MOTION TO DISMISS THE PETITION
UNDER 37 C.F.R. § 42.71(a)**

Pursuant to 37 C.F.R. § 42.71(a), Petitioner Cisco Systems, Inc. (“Cisco”) and Patent Owner TracBeam, LLC (“TracBeam”) (collectively, the “Parties”) jointly move for dismissal of the Petition for *Inter Partes* Review of U.S. Patent No. 7,525,484 (“the `484 Patent”). The filing of this motion was authorized by the Board via e-mail dated November 16, 2018.

The Parties have settled their dispute with respect to the `484 Patent and have reached agreement to seek termination of Cisco’s IPR challenge against the `484 Patent.
