Pursuant to 37 C.F.R. § 42.70(a) and the Scheduling Order dated May 10, 2019 (Paper 14), Patent Owner Almirall, LLC respectfully submits this Request for Oral Argument. As set forth in the Scheduling Order, the Board has scheduled oral argument for February 7, 2020. Paper 14 at 9.
