1	PROCEEDINGS
2	JUDGE BAER: All right. Good afternoon,
3	everyone. I think we're ready to go. We have,
4	this afternoon, our hearing for both
5	IPR 2019-00251 and 2019-00510, between Petitioner,
6	Apple, and Patent Owner, UNILOC. I'm Judge Baer,
7	and Judges Medley and Smith are here as well. So
8	the way this is going to work is we're going to
9	start with the 2019-00251 case, which is the case
10	addressing the '049 patent. We'll do that full
11	hearing, and then what we'll do is we'll take a
12	short break, and we'll then pick up, then, with
13	the 2019-00510 case, which is patent the
14	'079 patent.
15	For the record, let's go ahead and get the
16	party's appearances if we could. Who do we have
17	for Petitioner Apple?
18	MR. RENNER: Thank you, Your Honor. This
19	is Karl Renner, and I'm joined by Jeremy Monaldo,
20	as well as Matt Clements, from Apple.
21	JUDGE BAER: Great. And, Mr. Renner, will
22	you be presenting argument in both cases?
23	MR. RENNER: Your Honor, Jeremy Monaldo
24	and I will be dividing the responsibilities and

- 2 JUDGE BAER: So will you be splitting the
- 3 cases, one doing one case and the other doing the
- 4 other; is that correct?
- 5 MR. RENNER: He and I will both be
- 6 splitting the case in the first instance, the 251
- 7 proceeding; and the second proceeding, it will
- 8 likely be Mr. Monaldo only.
- 9 JUDGE BAER: Okay. Great.
- 10 And who do we have for Patent
- 11 Owner, Uniloc?
- MR. MANGRUM: Good afternoon, Your Honor.
- 13 This is Brett Mangrum, counsel for Patent Owner.
- 14 I will be speaking in both cases, and I believe I
- am the only person on the line for Patent Owner
- 16 today.
- 17 JUDGE BAER: Great. Thank you,
- 18 Mr. Mangrum. Welcome to you all. It's good to
- 19 have you here. We certainly appreciate everybody
- 20 making the effort to be here and to accommodate
- 21 these sort of unusual circumstances and doing this
- video conference. We appreciate everybody being
- 23 flexible with that.
- So we set forth the procedure in our trial
- order, but just a quick reminder: The parties



- 1 will have 45 minutes of total time to present
- 2 their argument in each proceeding. So 45 minutes
- 3 total time for the 251 case, and 45 minutes of
- 4 total time for the 510 case. We do have the full
- 5 record and the slides that you-all sent to us, and
- 6 we will be following along.
- 7 It will be helpful, just to keep things
- 8 clear, if you would, please, to reference where
- 9 you are, reference the exhibit and the page
- 10 number, or reference the slide number. That will
- also help keep our transcript clear.
- 12 Two things that will help, since we're
- doing this via video, the first is, if you're not
- speaking, if you would please mute your line,
- 15 which I think everybody is already doing. Also if
- 16 it's been a while since you've been speaking, if
- 17 you would identify yourself so we make sure our
- 18 court reporter knows who is speaking. I think
- 19 that's about it. Let's make sure we're ready to
- 20 go.
- 21 Does counsel for Petitioner Apple have any
- 22 questions?
- MR. RENNER: No, Your Honor. We'll just
- 24 mention we're planning to reserve 15 minutes of
- 25 the time for our redirect, though.
