**PETITIONERS' REQUEST FOR REFUND OF  
POST-INSTITUTION FEES**

The petition for *Inter Partes* Review of U.S. Patent No. 8,213,970 (Case No. IPR2019-00485) was denied by a Decision issued by the PTAB on July 1, 2019 (Paper No. 9). If a petition is denied, any post-institution fees paid by the Petitioners may be refunded.
