Patent Owner filed a Motion for *pro hac vice* admission of Andrew Hansen, (Paper 20), supported by a Declaration, (Exhibit 2022), in each of the above-identified proceedings.² The Motion is unopposed. Based on the facts set forth in the Motion and the accompanying Declaration, we conclude Mr. Hansen has sufficient legal and technical qualifications to represent Patent Owner, he has demonstrated the necessary familiarity with the subject matter of this case, and there is a need for Patent Owner to have counsel with his experience. FURTHER ORDERED that Mr. Hansen is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Title 37, Part 42 of the C.F.R., and is subject to the USPTO's disciplinary jurisdiction under 37 C.F.R. § 11.19(a) and the USPTO Rules of Professional Conduct as set forth in 37 C.F.R. §§ 11.101 *et seq.*; and

FURTHER ORDERED that Patent Owner shall file updated mandatory notices, pursuant to 37 C.F.R. § 42.8(b)(3), providing updated information regarding back-up counsel.
