Personal Comfort Bed History/Information-From Craig Miller

When people ask about where Personal Comfort Bed came from or mention Sleep Number always keep the conversation complimentary. Say things like: "Sleep Number is a great company, when they first started out in the 90's our parent company American National Manufacturing consulted and helped design their product and for a few years their products were created in our manufacturing facility. Things became so competitive in the recent years, Sleep Number paid us for 5 years not to compete with them. That non compete expired December 31st, 2011."

Craig said we can share the following information about the company too.

- Our parent company is American National Manufacturing (ANM) as well as SizeWise as the distributor of our medical mattresses. Both companies are BBB registered. (As of June 13th, 2013 Personal Comfort Bed is also BBB registered)
- FDA registered manufacturing facility: ANM's facility is FDA registered, the mattresses come from
 this facility, but technically the mattress is not FDA registered, the facility is. This means because
 ANM produces medical mattresses the entire manufacturing process and facility is FDA_
 registered as meeting the government standards for safety.
- Company wide we have over 1000 employees, ANM has 200 at the warehouse.
- American National produced air chamber beds for Bowflex who later purchased Nautilus Sleep Systems and later purchased Nautilus in 2006 and took over the servicing of the warranty for these products.
- Our medical mattresses were marketed to hospitals around the world through Kinetic Concepts Incorporated (KCI), a leader in hospital beds for the treament and prevention of bed sores.



While we were under the non compete we developed our FDA registered medical mattresses and are continuing to sell and service them in many hospitals and nursing homes across the country. Our non compete expired in 2012 and we are now offering these improved FDA registered mattresses to consumers like you and me at far reduced prices over Sleep Number and the other competing air chamber mattress companies on the market today. What size mattress are you shopping for today?

Our full history: We began in the bed industry making water beds in the 70's and began playing around with air chamber technology in the 80's. In the 90's a few business men came to our office, poked around and offered to purchase a few of our patents. These business men were representatives of Sleep Number. During the purchase of our patents, our company agreed to sign a non compete for many years not to manufacture and sell a competing mattress design. Durning this time we put our emphasis on the

medically approved mattresses we were also developing. These mattresses are most commonly used in hospitals and nursing homes. Some of our beds even rotate a patient all by remote control. Our manufacturing facility is FDA registered and our mattresses also carry this registration. This means our manufacturing facility as well as our mattresses are FDA registered and meet the medical standards of the Food and Drug Administration. Our non compete expired in 2012 and we have now used the new medical technology, experience with air chamber mattresses with the general public and improvements on our own patents and are able to offer our superior product to the general public at far reduced prices all with greater features and benefits over the competition.

As we offer factory direct pricing we can offer greater discounts for different types of payment. Our lowest sale prices are available when paying with debit or credit cards. We do offer financing as well with 0% options as well as some models up to 60 months. How were you planning on paying for your new mattress?

If you've already quoted a cash price and are approaching the financing question: "Our promo codes and financing options are separate promotions and can not be combined. Our financing options have great terms and offer 0% interest."

The lifetime warranty shows it's only limited to 20 years.

In general, the mattress industry agrees the lifetime of a mattress is 20 years. Our lifetime warranty covers the life of the mattress. The warranty is prorated with the first 3 years covered in full and we pay the shipping of all warrantied parts for the life of the warranty. Competitor's warranties may be longer, but their full years of coverage are fewer and they also make the customer pay shipping for replacement parts. (look up competitors warranties for specifics as they can change at any time) Years 21-25 with Sleep Number the customer pays 96% of the replacement value plus shipping in both directions. They charge the customer shipping for all parts to and from after their first 2 years. Our 20 year warranty is included with each and every mattress we sell, which mattress are you interested in today?

Dr. Oz recommends replacing your mattress every 8 years. All mattresses are not FDA registered and probably should be replaced more often.

Tell me about your 60 night trial,

Most of our mattresses come with a 60 night trial. This risk free trial offers you 60 full nights to try out the Personal Comfort Bed, after date of delivery, in your own home, not for 10 minutes on a showroom floor. We just ask that you give the bed 30 nights of rest before making any decisions. If at any time after the 30th night you are not completely satisfied, call our customer service department and we will pay your return shipping. We also offer a comfort exchange program where you can upgrade or downgrade your center panel to customize the mattress for both sleepers as well as fit your budget.
