ORDERED that Petitioner's Motion to Withdraw Counsel is *granted*;
FURTHER ORDERED that Jon H. Beaupré is no longer recognized as counsel for Petitioner in either of these proceedings; and
FURTHER ORDERED that Petitioner shall continue to have a registered practitioner represent it as lead counsel in these proceedings.
