The Board requested, via email, that Alphatec Holdings Inc. and Alphatec Spine, Inc. (“Petitioner”) and Nuvasive, Inc. (“Patent Owner”) indicate their availability for an oral hearing on Friday, April 3, 2020 and indicate whether they agree to have the oral hearing as part of the PTAB/TTAB Stadium Tour program being held at the University of Oregon School of Law.
