Dear PTAB:

Per SOP 9, Appx. 2, the parties are contacting the Board to arrange a teleconference with the panel regarding the remand from the Federal Circuit in IPR No. 2019-00610.

The parties have met and conferred regarding the procedure for the remand proceedings, and have agreed on the following joint proposal:

- (1) Within 2 weeks of the Board's decision on procedure, each side may file an opening brief not to exceed 10 pages.
- (2) Withing 2 weeks of the opening briefs, each side may file a response brief not to exceed 10 pages.
- (3) The additional briefing is limited to addressing the Federal Circuit's decision. The parties may not submit any new evidence or any new arguments on the underlying merits.
- (4) The parties agree that an additional hearing is unnecessary.
