For example, it included basic information about operation of the iPhone (its buttons and touchscreen display), setting up a user account, and app functionality. The last page of the Finger Tips Guide then referred users to the more detailed iPhone User Guide at the Apple Support site ([help.apple.com/iphone](http://help.apple.com/iphone) and [www.apple.com/support/iphone](http://www.apple.com/support/iphone)).


