PETITIONERS' REQUEST FOR ORAL HEARING

Pursuant to 37 C.F.R. § 42.70(a), Petitioners Apple Inc., Samsung Electronics Co., Ltd., and Samsung Electronics America, Inc. (“Petitioners”) submit this Request for Oral Hearing on the instituted grounds of unpatentability for claims 1, 8-9, and 15 of U.S. Patent 8,831,557 (“’557 patent”) under 35 U.S.C. § 103(a), and associated issues. Petitioners also request rebuttal to respond to all issues raised by Patent Owner’s presentation.

The Board already scheduled Oral Hearing for this and related proceedings—IPR2019-00612 for the ’557 patent, IPR2019-00613 for U.S. Patent 9,633,373 (“’373 patent”)¹, and IPR2019-00614 for U.S. Patent 9,779,419 (“’419 patent”)²—for May 5, 2020. IPR2019-00612, Paper 12 at 8; IPR2019-00613, Paper 13 at 6; IPR2019-00614, Paper 14 at 6. Petitioners’ counsel has conferred with Patent Owner’s counsel regarding the Oral Hearing. The parties jointly request Oral Hearing for the IPR2019-00612, IPR2019-00613, and IPR2019-00614 proceedings. The parties jointly propose that arguments for IPR2019-00612 on the ’557 patent be heard first with an allocation of one (1) hour per side, followed by arguments for IPR2019-00613 and IPR2019-00614 on the ’373 and ’419 patents with an allocation of one (1) hour per side.

¹ Case IPR2019-01011 has been consolidated with IPR2019-00613.

² Case IPR2019-01012 has been consolidated with IPR2019-00614.

Furthermore, in view of the USPTO's update on oral hearings scheduled to take place at USPTO offices on or after Friday, March 13, 2020, Petitioners intend to participate via remote video and/or telephone. Petitioners request the ability to use audio/visual equipment to display demonstratives and exhibits at the oral hearing, to the extent available at the time of the hearing.
