Patent Owner provides the following procedural background:

- On May 6, 2019, Petitioner filed its Petition in this proceeding, IPR2019-01035, challenging claims 1, 3, 4, 7, 9, 16, 17, 20, 21, and 22 ("Challenged Claims") of U.S. Patent No. 9,769,477 (the "'477 patent").
- On November 13, 2019, the Board instituted review of the Challenged
 Claims in this proceeding.
- On January 30, 2020, the Board issued its final written decision in IPR2018-01187, finding claims 1–6, 9–14, 20–22, and 25–27 of the '477 patent to be unpatentable.
- On April 15, 2020, the Board issued its final written decision in IPR2018-01630, finding claims 7, 8, 15–19, 23, 24, 28, and 29 of the '477 patent to be unpatentable.

In particular, the -01187 and -01630 IPRs together found unpatentable all the Challenged Claims at issue in this proceeding. Therefore, to promote efficiency and conserve the Board's finite resources, Patent Owner determined it was
