**PETITIONER REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioner, Huawei Technologies Co., Ltd., requests a refund in the amount of \$15,000 to be credited to Deposit Account Number 06-1050.
