1 I, L. Celeste Ingalls, hereby declare as follows:

2 1. I am a citizen of the United States, I am over the age of twenty-one,  
3 and I am neither a party nor an attorney for any party in this action.

4 2. I am employed by Alan H. Crowe & Associates, Inc., d/b/a Crowe  
5 Foreign Services, 1020 SW Taylor Street, Suite 240, Portland, Oregon, and I have  
6 specialized in the service of civil process in foreign countries for more than  
7 twenty-one years.

8 3. Since 2003, I have attended, at special invitation as a private expert,  
9 the Special Administrative Sessions of the Hague Conference in The Hague,  
10 Netherlands, at which each signatory country was represented by their respective  
11 Judicial Authorities to discuss the practical mechanics of, and problems  
12 encountered in dealing with, the Convention on the Service Abroad of Judicial and  
13 Extrajudicial Documents in Civil or Commercial Matters, Done at the Hague,  
14 November 15, 1965, (Hague Service Convention) as it applies to each country's  
15 laws and interpretations of the Convention and its obligations; and I have been an  
16 invited participant at a training session, presided over by the Hague  
17 Administration, to provide guidance to a foreign Central Authority and its courts  
18 on their practical obligations with respect to service under the provisions of the  
19 Hague Service Convention.

20 4. In mid-November 2016, Plaintiff Nomadix retained Crowe Foreign  
21 Services to prepare and submit a request to the Alberta (Canada) Central Authority  
22 that Guest-Tek Interactive Entertainment Ltd. be served with process in this action  
23 in accordance with the Hague Service Convention. The Central Authority that  
24 Canada has designated for the province of Alberta is the Ministry of Justice and  
25 Solicitor General, Justice Services Division, whose mailing address is Alberta  
26 Justice, Office of the Sheriff Civil Enforcement, 2nd Floor, 108th Street Building,  
27 9942-108 Street, Edmonton, Alberta T5K 2J5, Canada.

1           5.     On November 29, 2016, I forwarded a complete request for service of  
2 process under the Hague Service Convention to the Alberta Central Authority. In  
3 particular, I included (1) the requisite Hague documentation (Request, Summary,  
4 Hague Warning, and blank certificate) and (2) the documents from this action that  
5 Nomadix sought to serve on the defendant, which were: Summons in a Civil  
6 Action; Complaint for Breach of Contract with Exhibits 1–2 (including Exhibits  
7 2.0–2.22); Notice of Assignment to United States Judges; Order Re: Transfer;  
8 Standing Order; and Order Returning Case for Reassignment. The request  
9 specified that the entity to be served was Guest-Tek Interactive Entertainment Ltd.  
10 at Suite 600, 777 8 Ave SW, Calgary, Alberta T2P 3R5, Canada.

11           6.     In February 2017, I learned that the Alberta Central Authority had  
12 issued a Hague Certificate of service in response to the request I had submitted on  
13 behalf of Nomadix.

14           7.     Attached as Exhibit A is a copy of the Certificate that the Alberta  
15 Central Authority sent to my office in electronic form as a courtesy while I await  
16 the original hard copy of the certificate.

17           8.     This Hague Certificate indicates that Guest-Tek Interactive  
18 Entertainment Ltd. was served with process on January 12, 2017.

19           9.     My experience has been that the original hard-copy Hague Certificate  
20 from a Canadian authority is generally returned to me within approximately three  
21 weeks of the completion of service. Given this experience, I expect to receive the  
22 original hard copy of the Hague Certificate very soon.

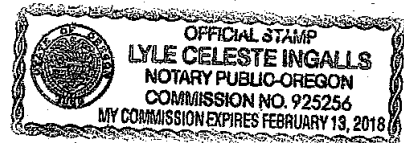

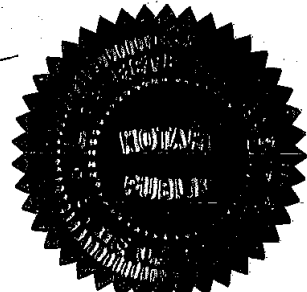
