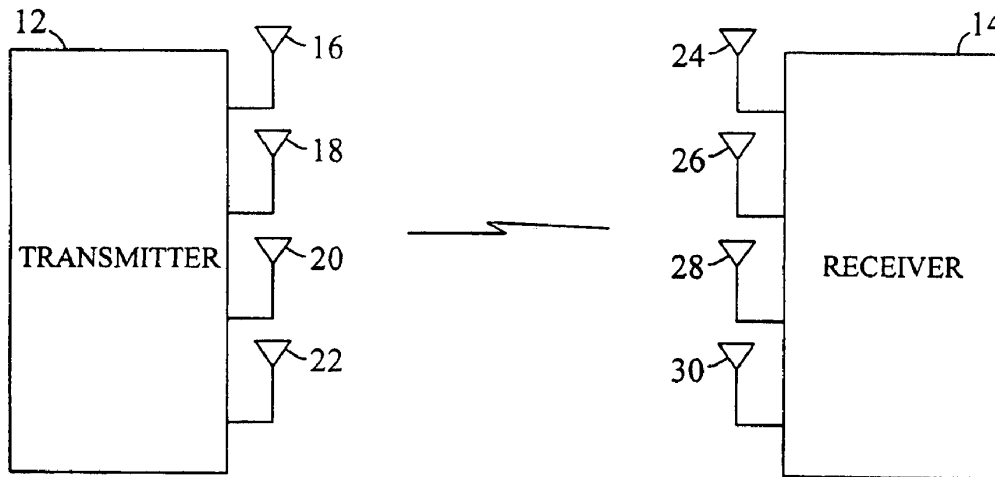
(57) **ABSTRACT**

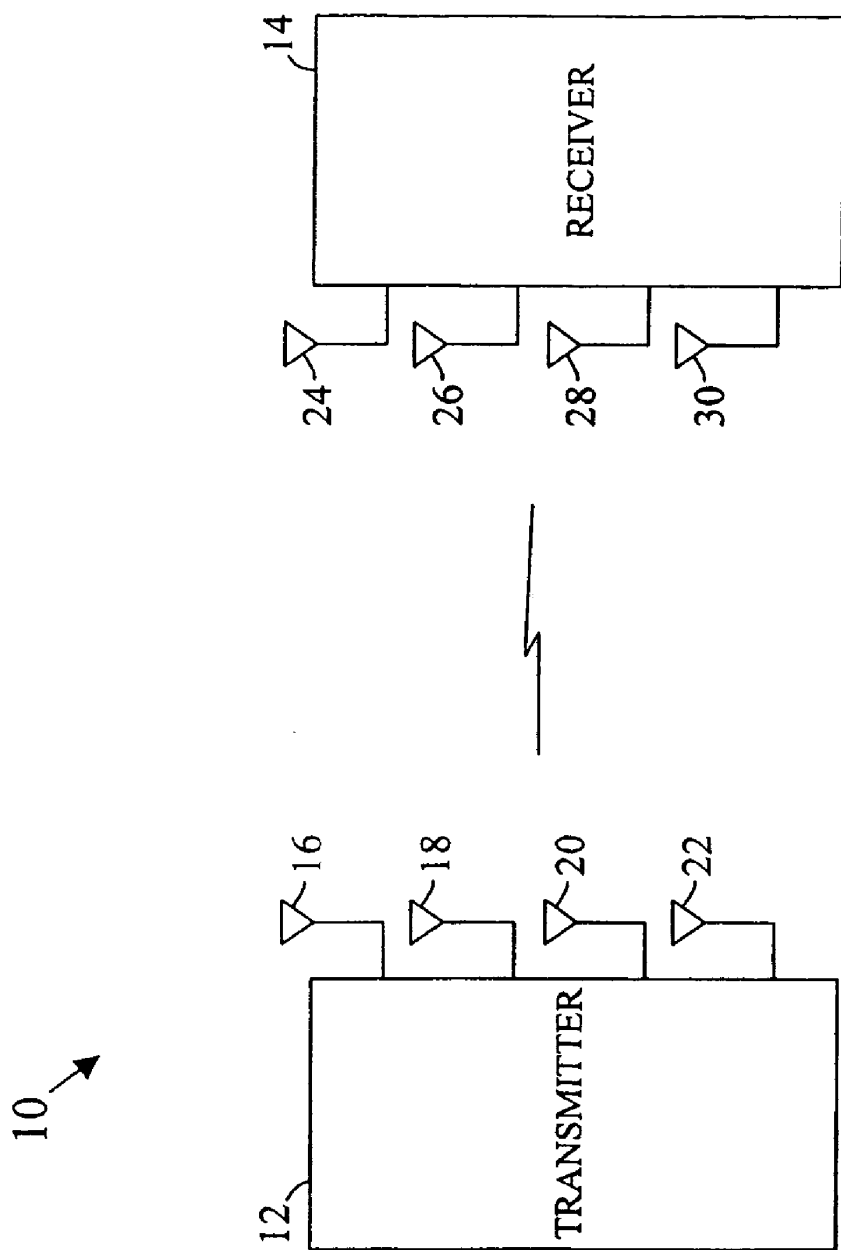

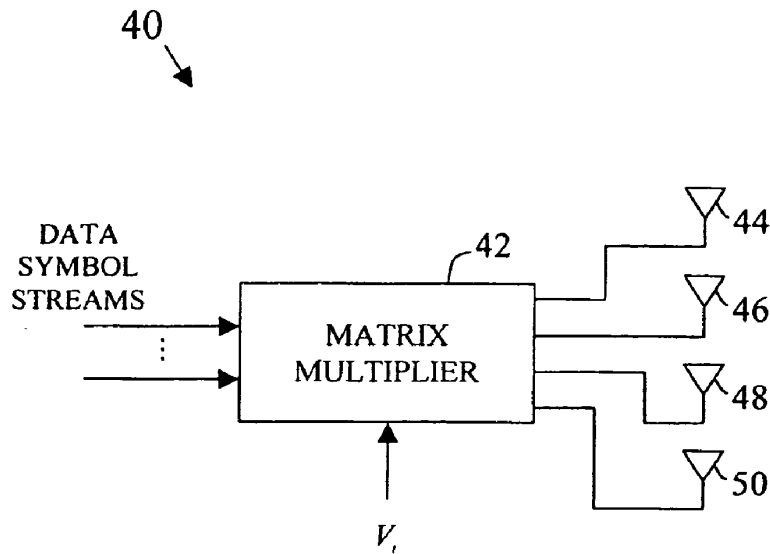

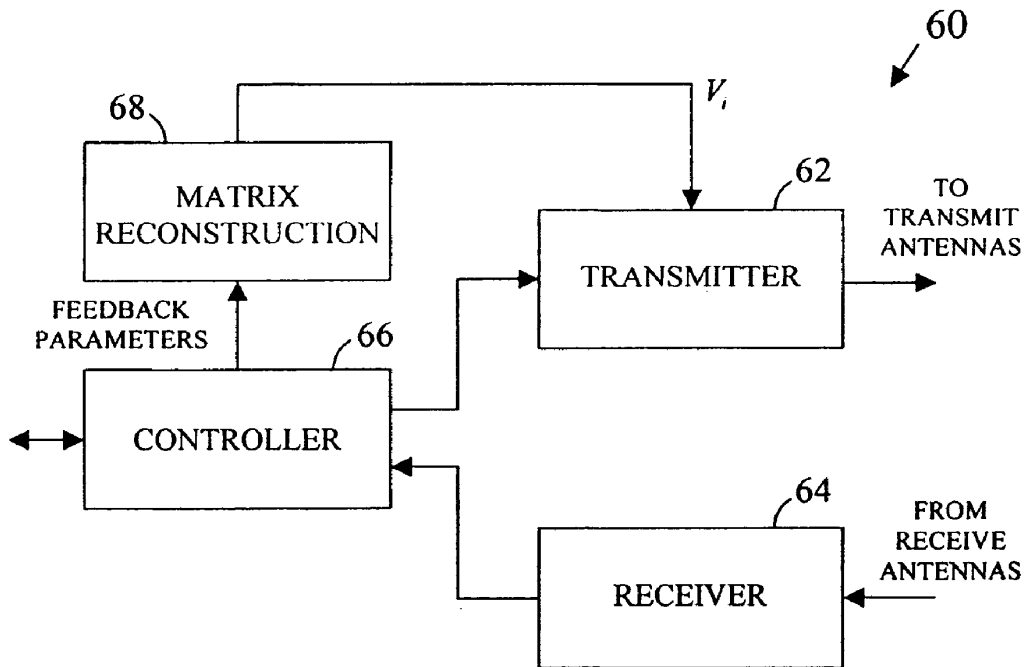

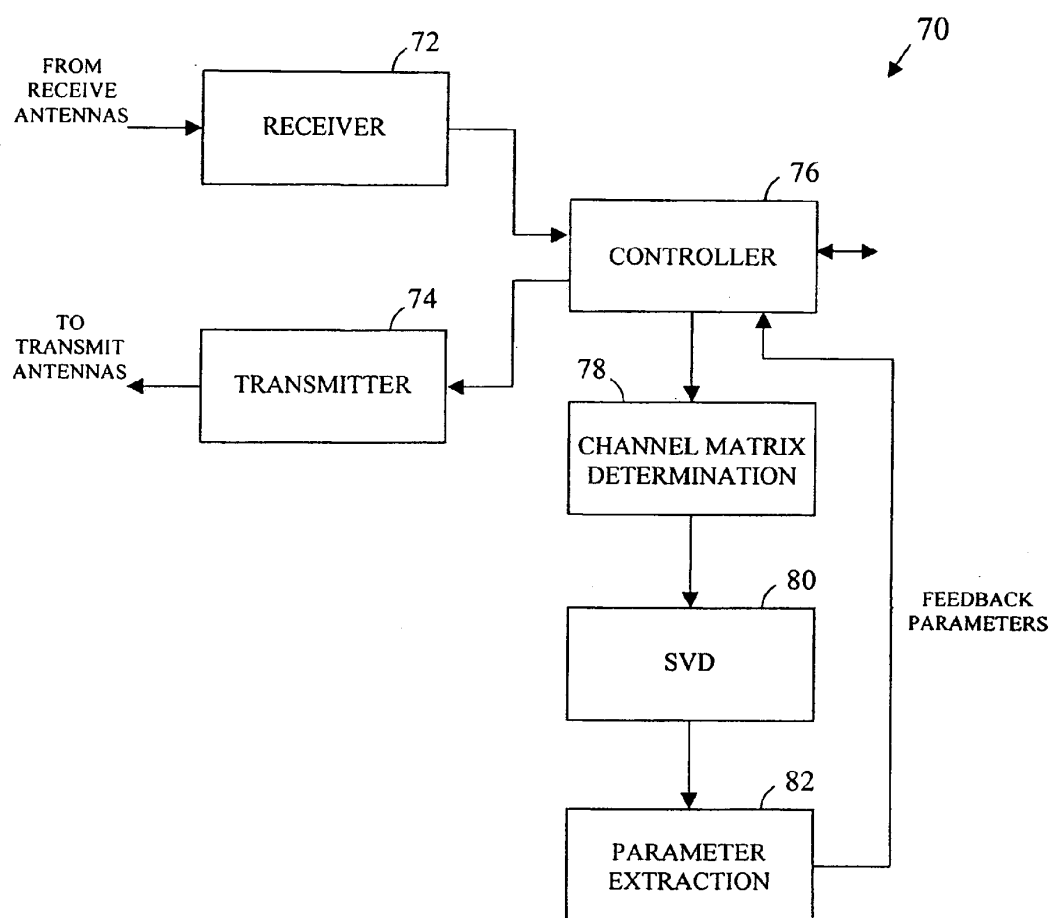

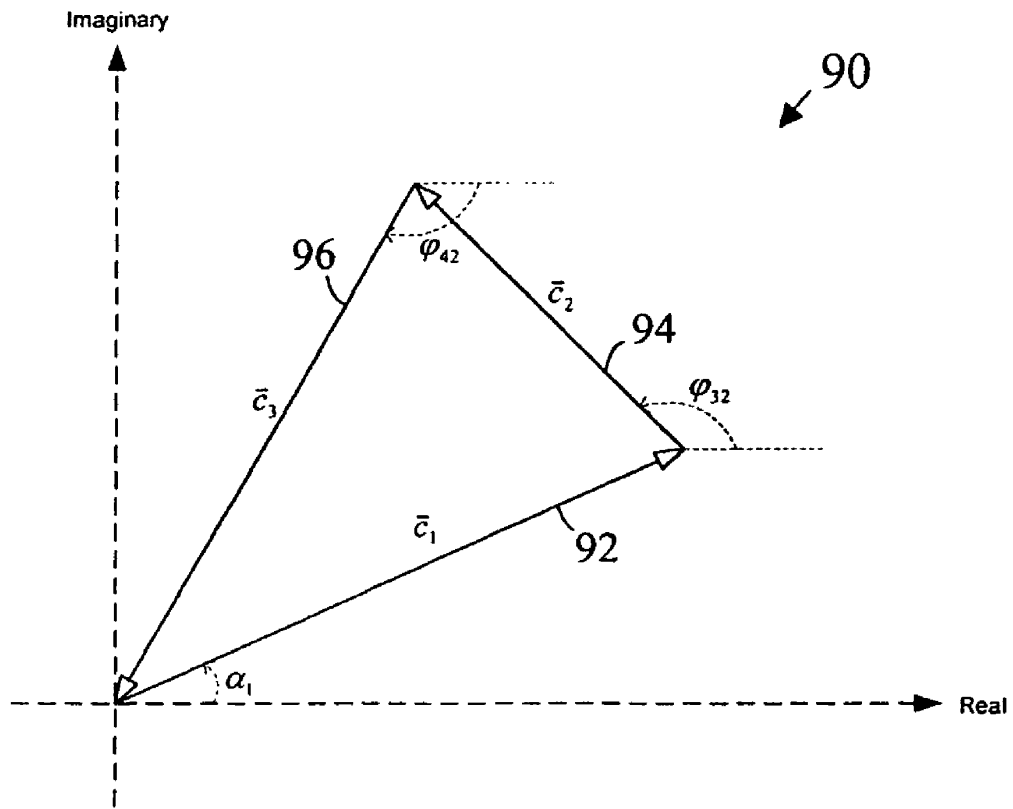
