PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

 - Claims 2-6 are not obvious over Ober, Nakazato, Cooper, and Windows ACPI;
 - Claims 8 and 9 are not obvious over Ober, Nakazato, and Doblar;
- Whether Windows ACPI qualifies as a printed publication;
- The timeliness of the arguments raised in the proceedings;
- The constitutionality of this proceeding;
- Any other relevant issues raised in papers filed in this proceeding, including issues raised in papers yet to be filed; and
- Any other issues that the Board deems necessary for issuing a Final Written Decision, including any questions, rebuttals, or arguments that may arise during the oral argument. The Board's advance guidance is respectfully solicited as to any questions the Board specifically wishes to be addressed.

Location: Patent Owner respectfully requests that oral argument be conducted remotely.

Time of day: Because Patent Owner's counsel is located in the Pacific Time Zone, it is respectfully requested that, if possible, oral argument be held in the afternoon.

Equipment: Patent Owner requests the ability to use a computer and screen to display possible demonstratives and exhibits.
