10	JUDGE DIRBA: Thank you, Mr. McKeever. And for Patent

12	MR. KOIDE: Good afternoon, Your Honors. This is
13	Brian Koide of the Etheridge Law Group for Patent Owner Uniloc
14	2017. And with me on the again, as I mentioned on the other
15	hearing, I believe on the telephonic line may be Uniloc's
16	general counsel, Steve Peterson.
17	JUDGE DIRBA: Thank you, Mr. Koide. Is there anyone
18	else on the line who would like to enter an appearance?
19	Okay. Please be aware that we received a request for
20	a public telephone line. As you all mentioned, there is a
21	telephone line active. So members of the public may be
22	listening to this hearing today. Neither party objected to
23	making the hearing publicly available, and the information of

1	There are a few things we'd like to address before
2	we get started today.
3	First, thank you all for your flexibility in
4	participating in this hearing by videoconference. Our first
5	priority is to ensure your right to be heard. So if at any time
6	you have a technical problem that you feel is undermining your
7	ability to adequately represent your client, please let us know
8	right away so that we can promptly address the problem. If you
9	are unable to speak with any of the judges, contact the team who
10	provided you with the connection information. We will pause the
11	action if a video participant or the court reporter loses their
12	audio or video connection. If that happens to you, please make
13	a note of what was being discussed at the time that you lost
14	your connection so that we can figure out where to pick up.
15	Also, to improve the audio quality during the hearing
16	today, please mute your mike and only unmute when speaking.

21	Petitioner has the ultimate burden of establishing
22	unpatentability; therefore, Petitioner will open by presenting

24	unpatentability of the challenged claims. Petitioner may
25	reserve rebuttal time no more than half of its total argument

1	time. Thereafter, Patent Owner will respond to Petitioner's
2	arguments. Patent Owner may likewise reserve surrebuttal time
3	of no more than half of its total argument time to respond to
4	Petitioner's rebuttal, if any.
5	All arguments presented today must have been
6	previously presented in your briefs. No new arguments are
7	allowed. Otherwise, the parties may use their allotted time to
8	discuss the case however they choose. We ask that you make it
9	clear which challenges and which claims you're addressing so
10	that the transcript is clear and so the judges can follow along.
11	We will not take objections during a party's argument.
12	Please hold your objections and present them at your next turn
13	to speak. I will maintain a clock and inform the parties when
14	they have approximately five minutes left in their presentation.
15	Are there any issues or questions that either party
16	would like to raise before we begin? I'll begin with
17	Mr. McKeever?
18	MR. McKEEVER: No questions at this time, Your Honor.
19	JUDGE DIRBA: And Mr. Koide?
20	MR. KOIDE: No questions, Your Honor.
21	JUDGE DIRBA: Excellent. Mr. McKeever, how long would
22	you like to reserve for your rebuttal?
23	MR. McKEEVER: I would like to reserve 10 minutes,
24	please, Your Honor.
25	JUDGE DIRBA: Okay. You may begin when you're ready.
