### **1. Real Party-In-Interest**

Teleflex Medical Devices S.A.R.L. is the real party-in-interest. Teleflex Innovations S.A.R.L. merged into Teleflex Medical Devices S.A.R.L. Teleflex also identifies the following additional real parties in interest: Vascular Solutions LLC, Arrow International, Inc., and Teleflex LLC. Teleflex Incorporated is the ultimate parent of the entities listed above.

### **2. Related Matters**

U.S. Patent No. RE45,380 (“’380 patent”) is the subject of litigation in two separate actions in the U.S. District Court for the District of Minnesota: *Vascular Solutions LLC, et al. v. Medtronic, Inc., et al.*, No. 19-cv-01760 (D. Minn., filed July 2, 2019); and (ii) *QXMedical, LLC v. Vascular Solutions, LLC*, No. 17-cv-01969 (D. Minn., filed June 8, 2017).

The ’380 patent is a reissue of U.S. Pat. No. 8,292,850 (“the ’850 patent”). The ’850 patent was previously at issue (i) in the U.S. District Court for the

District of Minnesota in *Vascular Solutions, Inc. v. Boston Scientific Corp.*, No. 13-cv-01172 (D. Minn., filed May 16, 2013), and (ii) at the PTAB in *Boston Scientific Corp. v. Vascular Solutions, Inc.*, IPR2014-00762, IPR2014-00763 (P.T.A.B., terminated Aug. 11, 2014).

The Petitioners in this IPR have also filed three other petitions challenging claims of the '380 patent, IPR2020-00128, IPR2020-00129, and IPR2020-00131.
