PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

Under 37 C.F.R. § 42.70(a) and the Board's May 8, 2020 Scheduling Order (Paper 10), patent owner respectfully requests oral argument on the issues raised in the Petition for Inter Partes Review of U.S. Patent No. 6,072,450, Patent Owner's Preliminary Response, Patent Owner's Response, Petitioner's Reply, and Patent Owner's Sur-Reply relating to the four instituted grounds, rebuttal to petitioner's presentation on all matters, and any other issues that the Board deems necessary for issuing a final written decision.

Patent owner respectfully requests 45 minutes per side of argument time. The argument is scheduled for February 9, 2021. (Paper 10 at 10.) The four instituted grounds are:

- Ground I: Anticipation of claims 1–2, 4–8, and 15–16 by Utsugi
- Ground II: Obviousness of claims 1–2, 4–8, and 15–16 over Utsugi
- Ground III: Obviousness of claim 3 over the combination of Utsugi and Manabe
- Ground IV: Obviousness of claims 9, 11–13, and 17–18 over the combination of Utsugi and Eida

If the oral argument will be conducted in person, patent owner also requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a projector to be connected to a laptop, and a document camera for displaying documents of record. In accordance with the Trial Practice Guide, Fed. Reg. Vol. 77, No. 157, at 48768, Patent Owner will contact the Board Trial Division paralegal to discuss logistics relating to oral argument.
