PETITIONER'S REQUEST FOR ORAL ARGUMENT

Pursuant to 37 C.F.R. § 42.70 and the Board's Scheduling Order of May 26, 2020 (Paper 7) (the "Scheduling Order"), Petitioner LG Electronics Inc. ("Petitioner") respectfully requests oral argument in connection with this proceeding (IPR2020-00179). Per the Scheduling Order, the oral argument will take place on February 8, 2021.

- That per 35 U.S.C. § 103, claim 5 of U.S. Patent No. 6,844,990 is unpatentable as obvious over Tada in view of Nagaoka;
- That per 35 U.S.C. § 103, claim 5 of U.S. Patent No. 6,844,990 is unpatentable as obvious over Tada in view of Baker;
- Rebuttal to issues raised by Patent Owner;
- Any other motions filed by either party; and
- Any other issues that the Board deems necessary for issuing a final written decision in this proceeding.
