

[57] **ABSTRACT**

An image is picked up by a camera comprising a fisheye lens having a relationship of $h=n\cdot f\cdot tan(\theta/m)$, wherein h is the height of an image of a subject at a certain point, f is the focal distance of the fisheye lens, θ is a field angle, m has a value of $1.6 \le m \le 3$, and n has a value of $m-0.4 \le n \le m+0.4$, and the image data of which is output from the camera, is converted into a plane image by an image data processing unit, and this converted image is then output to a monitor unit. Preferably, n and m both equal 2.






