The agreed claim constructions are as follows:

<i>Term / Phrase</i>	<i>Agreed Construction</i>
“transistor array substrate” (’338 patent, claim 1)	“a layered structure composed of a bottom insulating layer through a topmost layer on whose upper surface pixel electrodes are formed, which contains an array of transistors”
“the pixel electrodes being arrayed along the interconnections between the interconnections on the surface of the transistor array substrate” (’338 patent, claim 1)	“the pixel electrodes are arrayed along the interconnections and located between the interconnections, and the pixel electrodes are on the surface of the transistor array substrate”
