Pursuant to 28 U.S.C. § 1295(a)(4)(A); 35 U.S.C. §§ 141(c), 142, and 319; 37 C.F.R. §§ 90.2(a) and 90.3; and Rule 4(a) of the Federal Rules of Appellate Procedure, Patent Owner Packet Intelligence LLC ("Packet Intelligence") hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision (Paper 48) entered on September 8, 2021 (attached hereto as Exhibit A); the Order denying Director Review (Paper 50) entered on November 22, 2021 (attached hereto as Exhibit B); and from all underlying orders, decisions, rulings, and opinions that are adverse to Packet Intelligence related thereto and included therein.

In particular, Packet Intelligence identifies the following issues on appeal: whether Mr. Hirshfeld—Commissioner for Patents, Performing the Functions and Duties of the Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office—had authority to deny Packet Intelligence's request for Director Review; the determination that Claims 1, 2, 7, 16, and 18 of U.S. Patent No. 6,771,646 are unpatentable under 35 U.S.C. § 103(a); any finding or determination supporting or relating to these issues; and all other procedural or substantive issues decided adversely to Packet Intelligence in any order, decision, ruling, or opinion by the Board in IPR2020-00337.
