**RETURNABLE ITEMS**

- Products must be in the original, sealed Apotex labeled containers or original, sealed containers as distributed by Apotex.
- Apotex will accept product up to six (6) months before expiration date and up to six (6) months after the expiration date.
- All returns are subject to approval.
- This policy is subject to the laws within the governing jurisdiction of the customer.

**NON-RETURNABLE ITEMS**

- Products with more than six (6) months remaining shelf life OR more than six (6) months beyond expiration date.
- Repackaged goods, partials, free goods, samples, short-dated items sold as such, items sold on a non-returnable basis, or product that is not sent to Genco Pharmaceuticals for processing.
- Products missing label or lot number and expiration date.
