



## Comparing scheduling orders to trial dates

These charts compare jury trial dates set in the initial scheduling order to the date of the earliest verdict in that case. Data was taken from a sample of 177 cases chosen for the ability of their indicating docket text. Early (rather than late) trials were exceedingly rare and have been excluded from this data.

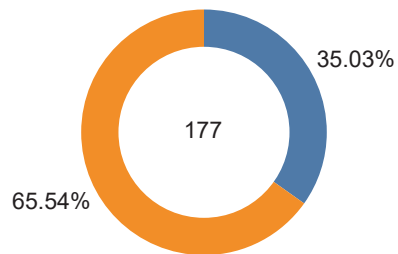
Verdict within 30 days of initial trial date

Verdict more than 30 days from initial trial date

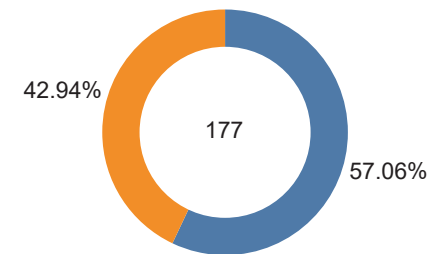
Verdict within 120 days of initial trial date
