5 Channel coding, multiplexing and interleaving

Data and control streams from/to MAC layer are encoded/decoded to offer transport and control services over the radio transmission link. Channel coding scheme is a combination of error detection, error correcting, rate matching, interleaving and transport channel or control information mapping onto/splitting from physical channels.

5.1 Generic procedures

This section contains coding procedures which are used for more than one transport channel or control information type.

5.1.1 CRC calculation

Denote the input bits to the CRC computation $by_a a_0, a_1, a_2, a_3, \dots, a_{A-1}$, and the parity bits $by_a p_0, p_1, p_2, p_3, \dots, p_{L-1}$. *A* is the size of the input sequence and *L* is the number of parity bits. The parity bits are generated by one of the following cyclic generator polynomials:

- $g_{CRC24A}(D) = [D^{24} + D^{23} + D^{18} + D^{17} + D^{14} + D^{11} + D^{10} + D^7 + D^6 + D^5 + D^4 + D^3 + D + 1]$ and;
- $g_{CRC24B}(D) = [D^{24} + D^{23} + D^6 + D^5 + D + 1]$ for a CRC length L = 24 and;
- $g_{CRC16}(D) = [D^{16} + D^{12} + D^5 + 1]$ for a CRC length L = 16.

The encoding is performed in a systematic form, which means that in GF(2), the polynomial:

 $a_0 D^{A+23} + a_1 D^{A+22} + \ldots + a_{A-1} D^{24} + p_0 D^{23} + p_1 D^{22} + \ldots + p_{22} D^1 + p_{23}$

yields a remainder equal to 0 when divided by the corresponding length-24 CRC generator polynomial, $g_{CRC24A}(D)$ or $g_{CRC24B}(D)$, and the polynomial:

 $a_0 D^{A+15} + a_1 D^{A+14} + ... + a_{A-1} D^{16} + p_0 D^{15} + p_1 D^{14} + ... + p_{14} D^1 + p_{15}$

yields a remainder equal to 0 when divided by $g_{CRC16}(D)$.

The bits after CRC attachment are denoted by $b_{a}, b_{a}, b_{a}, b_{b}, b_{b-1}$, where B = A + L. The relation between a_{k} and b_{k} is:
