FIG. 6 is a rear view of the vehicle body.

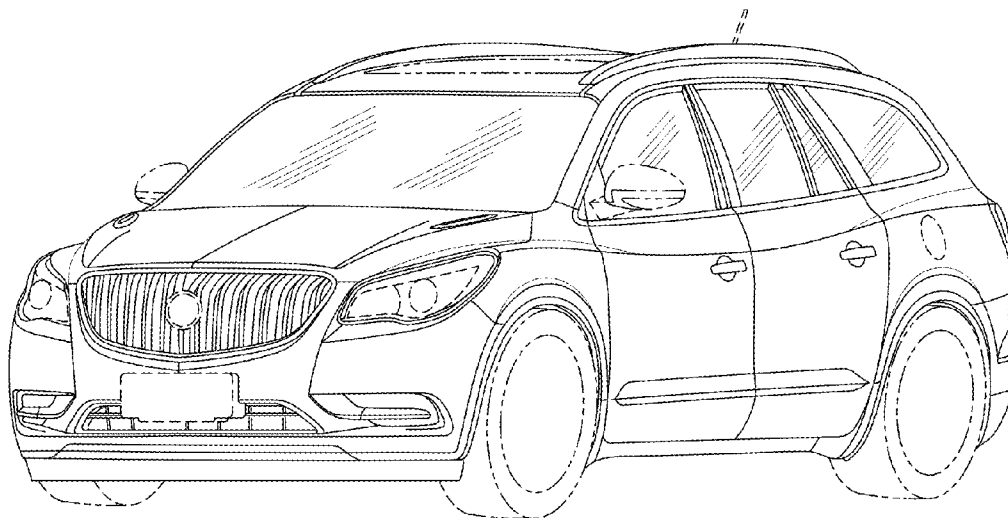

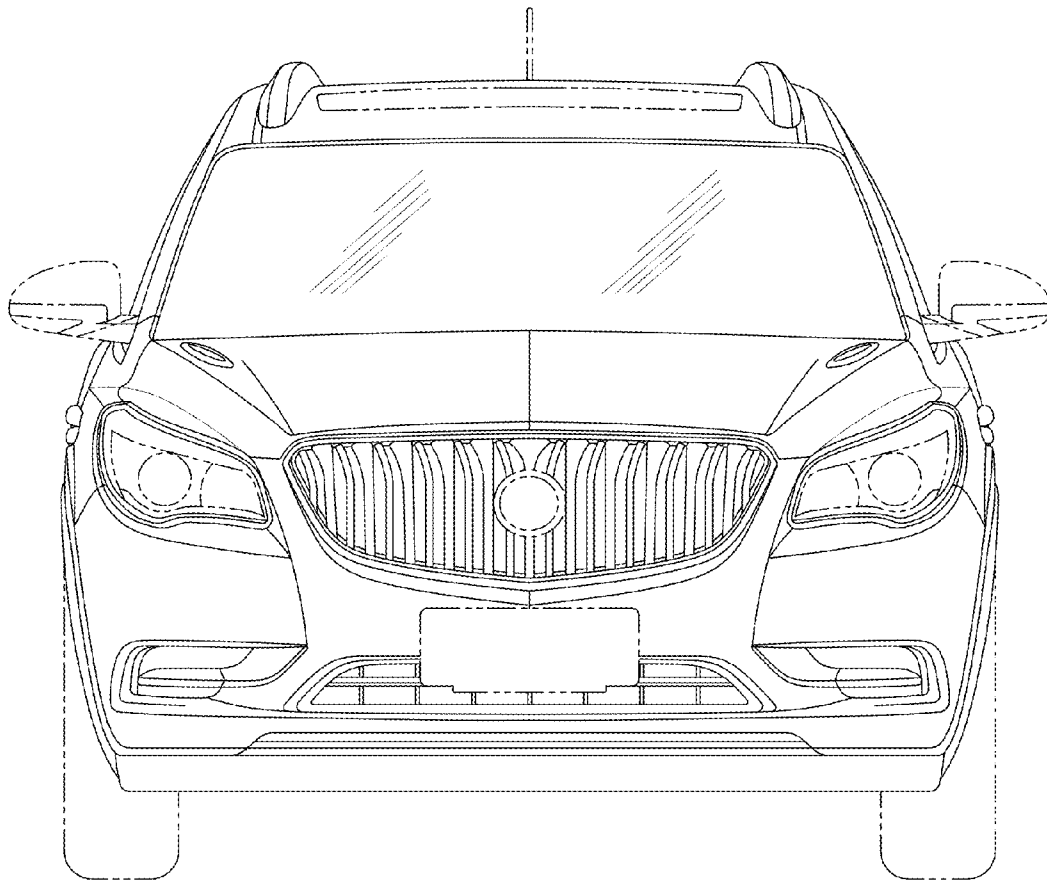

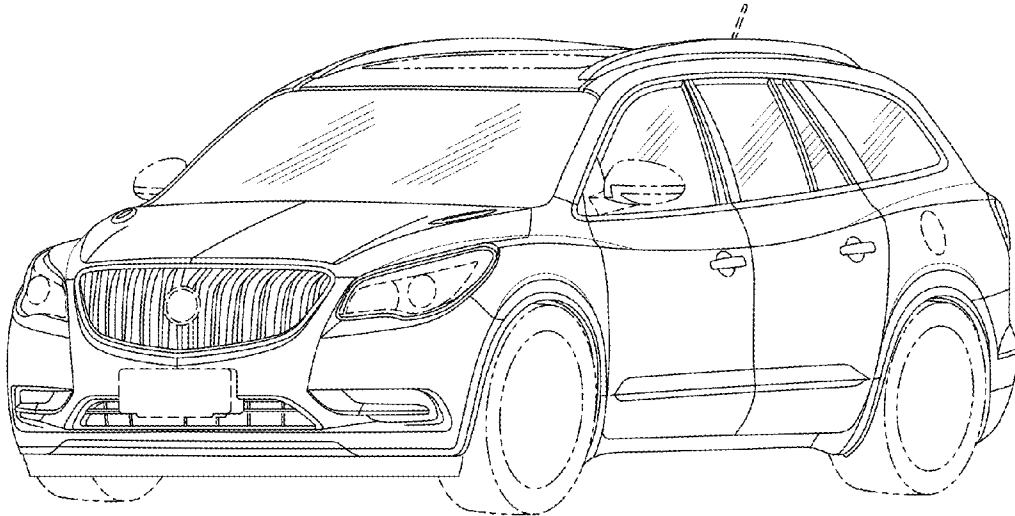

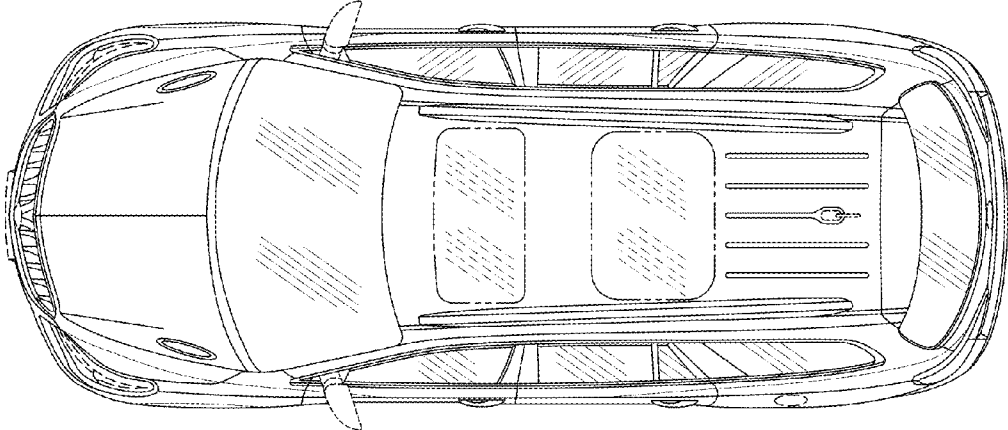

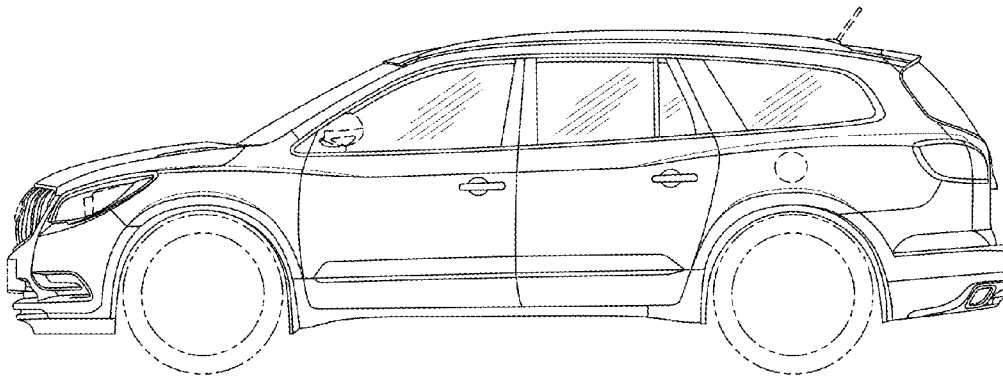
