### DESCRIPTION

FIG. 1 is a front view of the vehicle body exterior;

FIG. 2 is a front and left side perspective view thereof;

FIG. 3 is a left side elevation view thereof (where the right side elevation view is a mirror image except that the right side elevation view would not depict a gas cap cover);


FIG. 4 is a top plan view thereof;









