

Pursuant to Civil Local Rule 7-12, Plaintiff Uniloc 2017, LLC ("Uniloc") and Defendant Google LLC ("Google") jointly submit this stipulated request for an order staying the present litigation pending *Inter Partes* Review ("IPR") by the Patent Trial and Appeal Board ("PTAB") of U.S. Patent No. 8,949,954 ("the Patent-in-Suit"). The parties jointly stipulate and submit as follows:

WHEREAS, Uniloc asserts in the present litigation that Google has infringed Claims 1-4, 6, 9, and 12-14 of the Patent-in-Suit;

WHEREAS, on July 17, 2020, the PTAB instituted IPR as to Claims 1-4, 6, 9, and 12-14 of the Patent-in-Suit in IPR2020-00441;

WHEREAS, pursuant to the Patent Statute, the PTAB must issue a Final Written Decision within one year of the date of institution, which may be extended by no more than six months for good cause shown (35 U.S.C. §§ 316(a)(11), 318(a));

WHEREAS, for purposes of judicial economy and to avoid the unnecessary expenditure of resources, the parties desire to stay the present litigation pending the final resolution of the IPR proceeding, including any appeals;

WHEREAS, the parties agree that within fourteen days from the final resolution of the IPR proceeding, the parties shall file a joint status update advising the Court of the decision;

WHEREAS, the parties reserve the right to later seek appropriate relief regarding whether any stay should or should not be continued.

NOW THEREFORE IT IS HEREBY STIPULATED by the parties through their respective counsel, subject to the approval of the Court, that the above-captioned action is hereby stayed until further order of the Court.

IT IS SO STIPULATED.
