Pursuant to 35 U.S.C. § 317(b), 37 C.F.R. § 42.74(c), and the Board's authorization via email on November 17, 2021, Petitioner HP, Inc. and Patent Owner Syncloud Technologies LLC jointly request that the Settlement Agreement (Exhibit 2040) referenced in the concurrently-filed Joint Motion to Terminate Proceeding be filed as business confidential information. This Settlement Agreement describes the highly confidential terms of the parties' single settlement, which constitutes confidential commercial information under the Board's rules. *See* 37 C.F.R. § 42.54; Office Patent Trial Practice Guide, 77 Fed.
