FURTHER ORDERED that Steven B. Kelber is withdrawn as counsel for Patent Owner in each of the above-captioned proceedings; and

FURTHER ORDERED that Dr. Gregory J. Gonsalves is recognized as lead counsel for Patent Owner in the above-captioned proceedings.
