(57) **ABSTRACT**

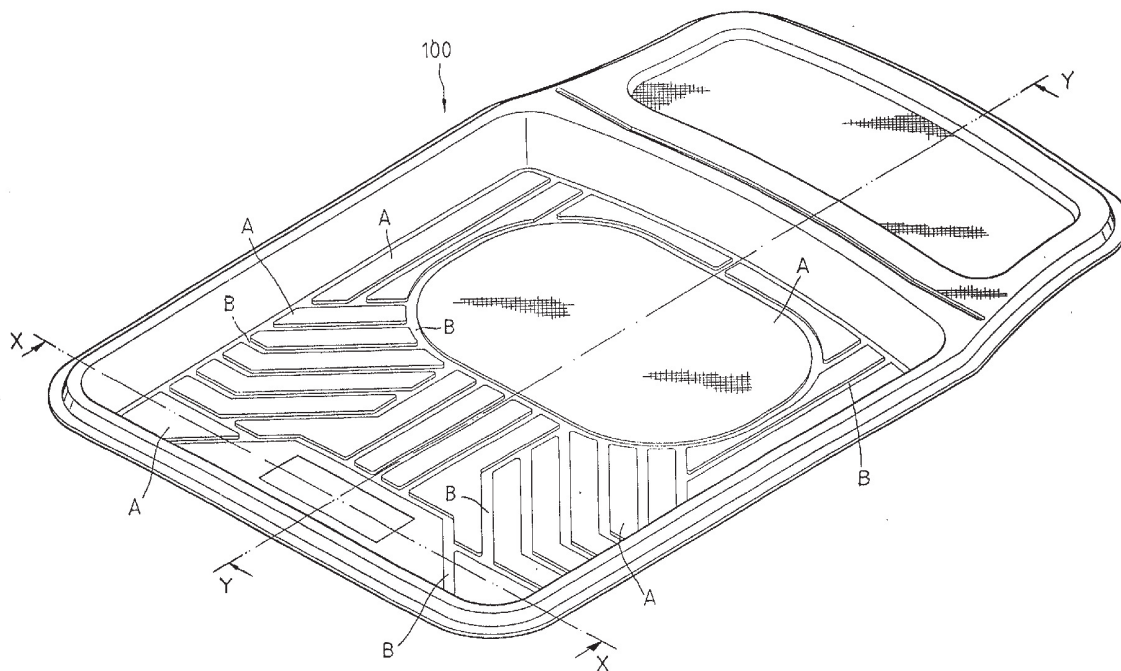
An improved mat used in cars includes an upper polyester fabric, a middle plastic plate or layer, and an under net lining. All three parts are stuck together, and bound to form a plate-shaped object. The plate-shaped object of the mat is formed by multiple symmetrical umbos. There are multiple symmetrical bevel grooves formed between these umbos naturally, and the grooves are downward. The sideways grooves therefore can collect the muck on the shoes, and is convenient for people to take the mat out to wash without dirty the carpet. Additionally, multiple foam particles are created on the under net lining of the mat. The mat will not move on the carpet by these foam particles.

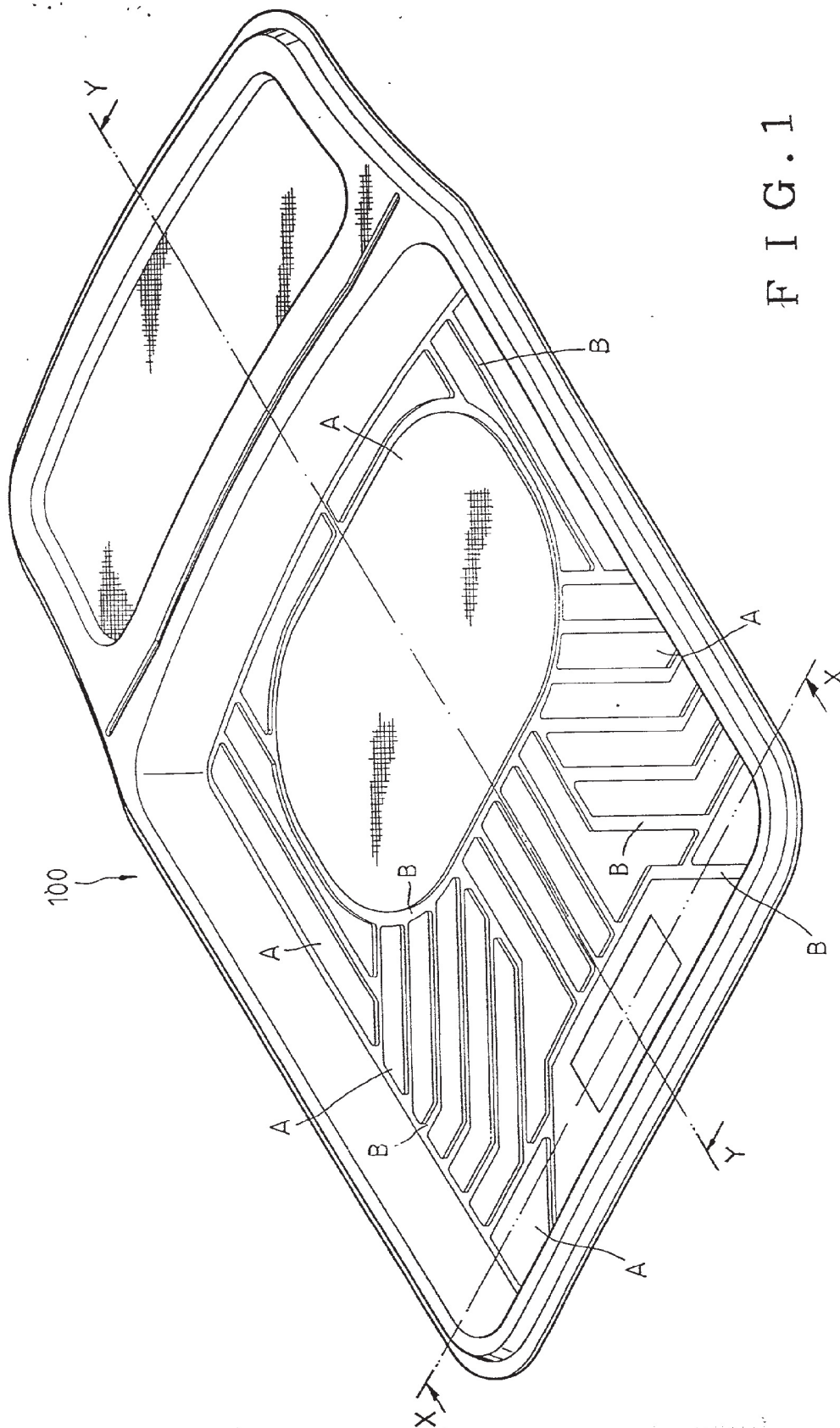

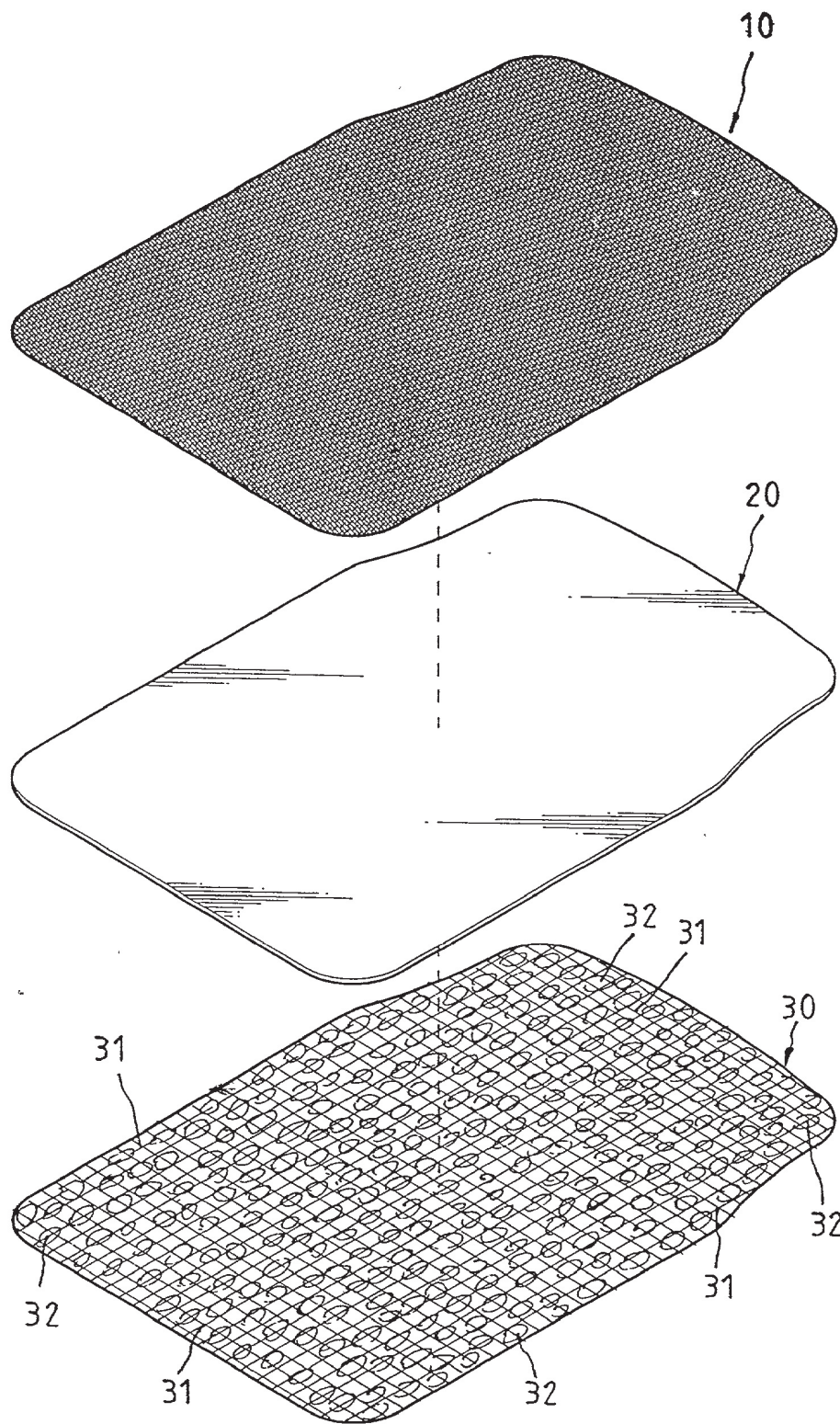

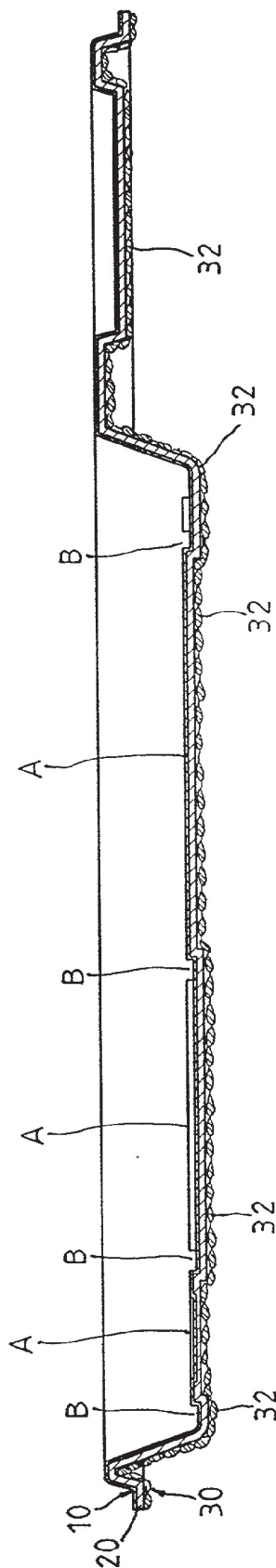

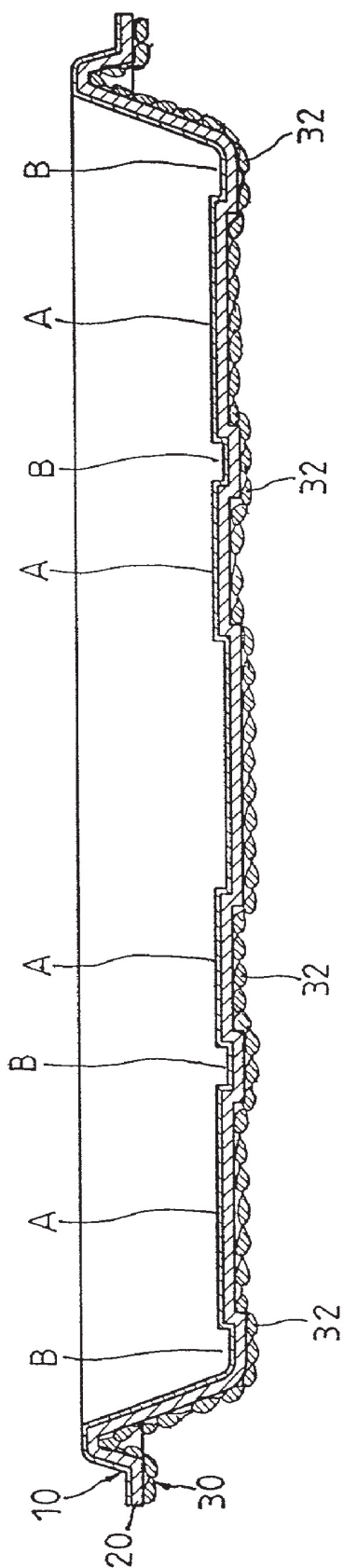
