(57) **ABSTRACT**

Nucleosides and nucleotides are disclosed that are linked to detectable labels via a cleavable linker group.






Uridine C5-linker




Cytidine C5-linker




N7 Deazaadenosine C7-linker



N7 Deazaguanosine C7-linker




Adenosine N6-linker

Disulfide Linker


