In light of the PTAB's recent institution decision in IPR2020-00988, Patent Owner Columbia withdraws its arguments under 35 U.S.C. § 314(a) in IPR2020-01065, -01125, and -01177. Columbia previously withdrew the same arguments in IPR2020-01323. See IPR2020-01323 Patent Owner Sur-Reply, Paper 15 at 1 n.1 (December 16, 2020). Illumina does not object to this action.
