- Intro - ppt slides

- Demo TV - Marketplace and Community screens
- Demo Web (Classifieds) - web app
- 1 Works - ppt slides.

This beauty of this was that all of this was re-formatted in .html . The Demo Web (classifieds) selection opens up a separate window.

THEN...

Tim came up with a new Powerpoint and said " I want the this slide to play the video and this slide to bring up the demo."

So we basically inserted the video into his Powerpoint and launched the demo (described above) to the screen he selected (the one with the Channel1 logo). This was when we were all sitting in the Oceanic lab testing the relative links.

The link to the original demo is in effect another window from the Powerpoint. The original demo includes the original Powerpoint screens (embedded in the .html) if you were to click on Intro or 1Works. Confused?

I could take out all but the pertinent selections in the Investor version...and leave only

- Demo TV - Marketplace and Community screens
- Demo Web (Classifieds) - web app

but that won't prevent the demo from opening up in another window because you are launching the .html demo from a Powerpoint.
