Scott,

I run a start up out of Hawaii that has an interactive advertising service up and running in Hawaii, partnered with Oceanic.

For the last 18 months we have been operating a VOD based service (similar to Cox San Diego's Freezone). We are about to launch a more interactive service that includes a 'community' area where small businesses, community organizations and even individuals can "publish to TV."

We are in discussions with a number of other TWC divisions about deploying this service, and plan to market it broadly this summer starting with the NCTA show and the NCTC meeting.

We are not a technology company. We create services and value add applications for cable utilizing existing technology, and provide the services required to launch and maintain these applications. Nate has encouraged us to talk to you. He is very high on your technology.
