Hello Yves -

I regret that I have been out of touch for several weeks; we fell into a period of intense traveling and product development, leaving little time for anything else. Things are settling down a bit and I am able to focus on other issues, finally...

I would like to reengage our dialogue, as I am very interested in the UI possibilities that Bluestreak could bring to our products. I have a few questions that I would appreciate your consideration:

- * As a brief reminder, BBiTV is developing two distinct product lines: 1) iTV applications and support services for local cable ad sales that allow the cable operator's ad sales groups to package iTV ad presentations and VOD with their spot sales and 2) a web and iTV-based platform to allow the community to publish content (classifieds, announcements, etc.) directly to the local iTV platform. VOD is important for both products but critical for the ad sales product. The ability to handle large numbers of images to be overlaid over backgrounds is critical to the community product (photos for classifieds, announcements, personals, etc.)
- * I do not see from my notes of our conversation on May 26th whether we discussed Bluestreak's support for ISA-compliant VOD stream control nor do I see it explicitly discussed in the literature I have received from Bluestreak. Do you offer or plan to offer this capability and in what timeframe?

Current plan with TWC calls for integration of their ISA-compliant client. Since they already have a VOD client we will use it and exposed its functionalities through Java-Script object. Unfortunately I can't give you a firm date on the availability in the field. If it becomes critical to your deal with them, they can put a higher priority to it.

* Before we committed to your BDK Licensing Program, would you allow us to build one or two sample Flash apps at our facility and then carry these to your offices to do a hands-on port into your platform? It would be a meaningful exercise for us if you would consider it.

With the BDK licensing comes some training and support hours. It would be ideal that your Flash developers come to the training with one or two sample Flash apps. I can give you the developers' guidelines to limit their "excitements" on Flash animations and Java-Script code processes...

* Are you attending CTAM in Boston this month? I will be there and would be a good opportunity to get together.

Yes, I will be in Boston.
