The '116 patent is a reissue of U.S. Pat. No. 8,292,850 (“the '850 patent”). The '850 patent was previously at issue (i) in the U.S. District Court for the

District of Minnesota in *Vascular Solutions, Inc. v. Boston Scientific Corp.*, No. 13-cv-01172 (D. Minn., filed May 16, 2013), and (ii) at the PTAB in *Boston Scientific Corp. v. Vascular Solutions, Inc.*, IPR2014-00762, IPR2014-00763 (P.T.A.B., terminated Aug. 11, 2014).

The Petitioners in this IPR have also filed another petition challenging claims of the '116 patent, IPR2020-01344.
