INDEPENDENT CLAIMS 1 AND 15

- 1. Encapsulated krill oil comprising a capsule containing Euphausia sup krill oil suitable for oral administration, said krill oil comprising greater 30% phosphatidylcholine w/w of said krill oil, less than 3% free fatty w/w of said krill oil and astaxanthin esters.
- 15. Encapsulated krill oil comprising a soft gel capsule containing *Euph superba* krill oil suitable for oral administration, said krill oil comprising greater than 30% phosphatidylcholine w/w of said krill oil, **less than 36 fatty acids w/w of said krill oil**, less than about 3% lysophosphatidylchw/w of said krill oil and at least 100 mg/kg astaxanthin esters.
- Patent Owner is only contesting whether Petitioner has demonstrate Table 2 of Bottino II discloses a krill oil extract with less than 3% fracid (FFA) content.
