<p>An electrically-powered, aerosol-generating smoking article [10] comprising:</p>	<p>VUSE Vibe is an electrically-powered, aerosol-generating smoking article.</p> 
<p>an electrical power source [36] within a tubular outer housing [20] having a mouth-end [15] and an end distal to the mouth-end [13];</p>	

at least one electrical resistance heater [70, 72] powered by said electrical power source [36];



The vaporizer screw is made from brass and is nickelplated. This component engages the female threads on the power unit and forms part of the electrical circuit between the ground lead of the heater coil and the power unit ground.

a puff-actuated controller [50] within the tubular outer housing [20] and adapted for regulating current flow through the electrical resistance heater [70, 72] during draw, the controller [50] comprising a sensor [60] adapted for sensing draw on the smoking article [10] by a user; and













The PCBA drives the heater coil and two LEDs and is connected to the pressure sensor, the battery PCM and the battery electrode using solder. The pressure sensor is a commercial off-the-shelf (COTS) item that detects vacuum draw on the device relative to ambient pressure, which gains access to the pressure sensor by two thru holes in the PCBA.

a rod-shaped carrier device engaged with the mouth-end [15] of the tubular outer housing [20] and comprising a cartridge [85] providing a liquid storage compartment containing a mixture comprising a tobacco extract and an aerosol-forming material absorbed within an absorbent fibrous material, the cartridge having a generally tubular shape and adapted for airflow therethrough;

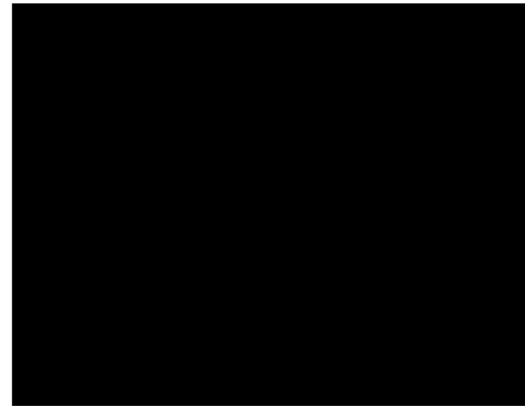
