PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

5. Any additional issues on which the Board seeks information or clarification.

Patent Owner requests 60 minutes of time per side for argument, with the opportunity to reserve some of the allotted amount of its time for a sur-rebuttal, if needed.

Patent Owner further requests the use of audio-visual equipment to assist its arguments, including a computer-connectable projector and a screen.

Patent Owner also requests the services of a court reporter to transcribe the proceeding.
