The parties in *GREE Inc. v. Supercell Oy* (2:19-cv-200, 237, 310, 311) jointly and respectfully request that this case be specially set for trial as the first case in this Court's May 10, 2021 trial calendar.

GREE's corporate representative and general counsel have been in the United States since February 20 in anticipation of the March 1 and March 15 trial settings, and face difficult quarantine restrictions both in Japan and the US that would make return to Japan before the April 5 setting practically impossible. In addition, the parties recently agreed to consolidate their separate action 2:19-cv-413, which was on the May 10 calendar, with a later case (2:20-cv-113) set on the August 2 trial calendar, thereby opening the spot on the May 10 trial calendar that this case held.
