ORDER NO. 41: INITIAL DETERMINATION EXTENDING THE TARGET DATE DUE TO CORONAVIRUS

(August 13, 2020)

The Target Date for completion of this Investigation was originally March 31, 2021. (*See* Order No. 2 (Oct. 17, 2019); Order No. 5 at App. A (Nov. 5, 2019).). Accordingly, the Initial Determination on Violation ("ID") in this Investigation was due on November 30, 2020. (Order No. 5 at App. A (Nov. 5, 2019).).

On April 17, 2020, due to extensions for all remaining deadlines in this Investigation as a result of the Coronavirus, including problems with disrupted travel and discovery, I extended the Target Date for completion of this Investigation to June 4, 2021 ("First Extension"). (Order No. 23 (Apr. 17, 2020).).

Since the First Extension, the Coronavirus has necessitated additional extensions to deadlines, including the need to postpone the evidentiary hearing to at least early November 2020, in order to work out logistical issues associated with holding the evidentiary hearing by remote video conference. Therefore, I am hereby extending the Target Date for completion of this Investigation to August 16, 2021. The new date for the issuance of the ID is now April 16, 2021.



Pursuant to 19 C.F.R. § 210.42(h), this Initial Determination shall become the determination of the Commission unless a party files a petition for review of the Initial Determination pursuant to 19 C.F.R. § 210.43(a), or the Commission orders on its own motion a review of the Initial Determination pursuant to 19 C.F.R. § 210.44.
