**PETITIONERS' REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On September 24, 2020, Samsung Electronics Co., Ltd., Samsung Electronics America, Inc., Sony Corporation, and Sony Mobile Communications Inc. (“Petitioners”) filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,749,251 (“the ’251 Patent”), which was assigned AIA review number IPR2020-01683 by the Board.
