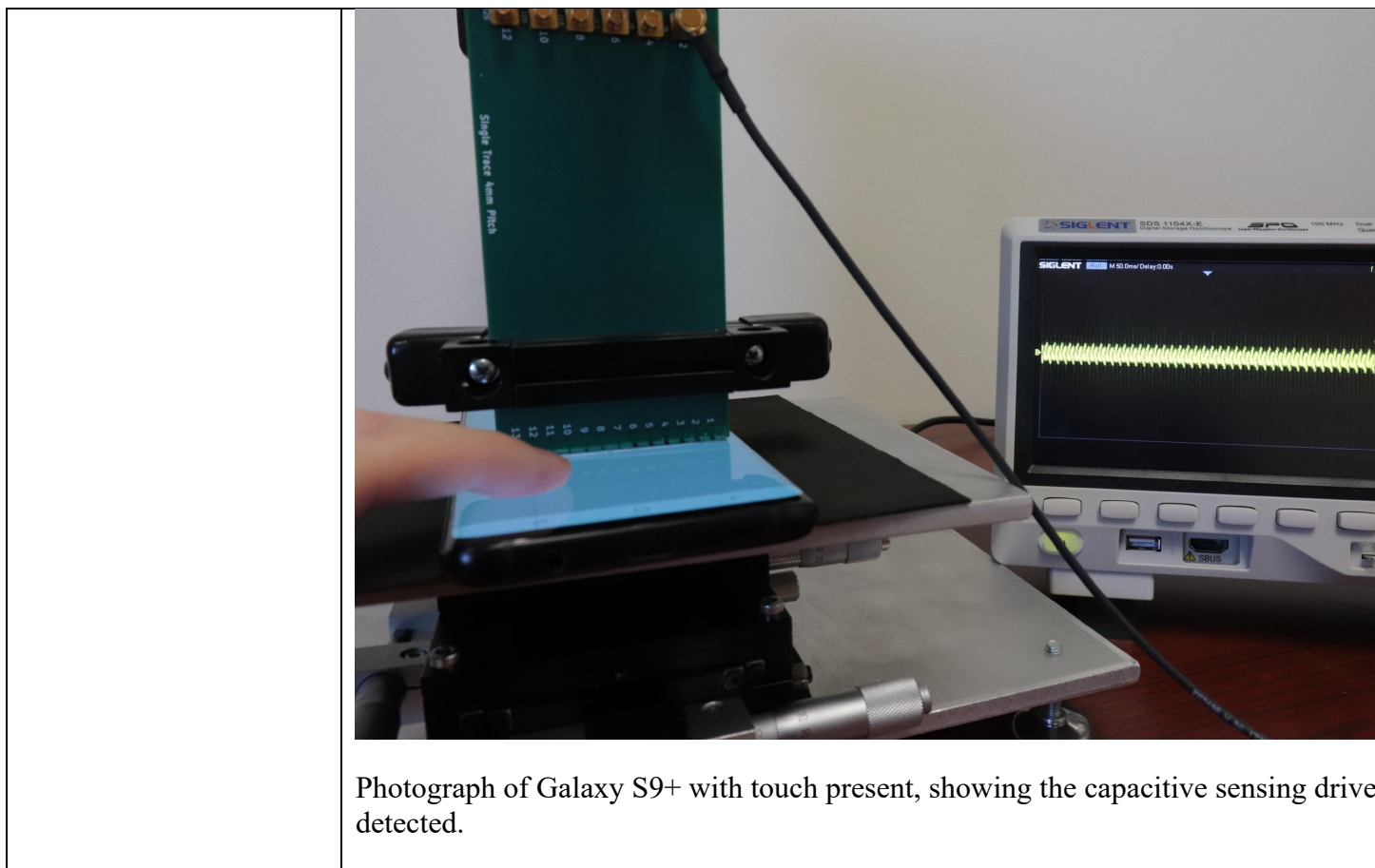

The Galaxy S9+ includes one or more computer-readable non-transitory storage media coupled to the sensing element and embodying logic that is operable when executed to perform the steps described below.

For example, the Galaxy S9+ includes one or more touch controllers or system processors coupled to the sensing element and embodying logic that is operable when executed to perform the steps described below.

This change is readily observable using a standard oscilloscope measuring the capacitive drive signal above the Galaxy S9+'s touch screen. There is a distinct difference between the drive signal observed while a finger touch is in contact with the drive signal observed after removing that touch.
