Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4,211, 4,233-34 (Jan. 18, 2013), Petitioner Palo Alto Networks, Inc. requests a refund in the amount of \$40,500.00 to be paid to deposit account number 19-0036.

On October 2, 2020, Petitioner filed a Petition for *Inter Partes* Review seeking review of claims 1-44 of U.S. Patent No. 8,243,593 (assigned case number IPR2020-01712) (Paper 6). On February 4, 2021, the parties filed a Joint Motion to Terminate *Inter Partes* Review (Paper 11). The Patent Trial and Appeal Board granted the parties Joint Motion to Terminate on February 11, 2021 (Paper 13). Trial was never instituted in this proceeding.
