- Grounds for which *inter partes* review was instituted for the '657 patent and any issue raised in the Board's Institution Decision dated May 11, 2021 (Paper 13);
- Any issue addressed in Petitioner's papers, including, but not limited to, the Petition and Petitioner's Reply Brief; and
- Rebuttal to Patent Owner's presentation on all issues, including the issues listed above and any issues raised in Patent Owner's Response and Patent Owner's Sur-Reply.

The oral argument for this proceeding (IPR2021-00104) and one other related proceeding in IPR2021-00103, which involves a related patent and similar issues, are both currently set for the same day, February 9. Petitioner respectfully requests the oral arguments in IPR2021-00103 and IPR2021-00104 to be consolidated, because Petitioner expects that consolidation of the oral arguments will benefit the Board.

Petitioner believes the parties should be allocated 120 minutes per side to present arguments in a consolidated oral argument for both proceedings.
