**REQUEST TO MODIFY SCHEDULE FOR SERVING  
ORAL HEARING DEMONSTRATIVES PER STIPULATION**

In the Board’s Order Setting Oral Argument, the Board ordered the parties to serve the demonstratives on opposing counsel at least seven business days before the hearing date, and file them no later than two business days before the hearing date. Paper 43 at 4. The Board also stated: “The parties may stipulate to an alternative schedule for serving and filing demonstratives, and request that the Board modify the schedule for filing and serving demonstratives at least seven (7) business days before the hearing date.” *Id.* at 4 n.5.

Petitioners Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. and Patent Owner Nanoco Technologies Ltd. have stipulated to a new deadline for exchanging the oral hearing demonstratives. The parties do not seek to change the deadline for filing the demonstratives. The following chart identifies revised deadlines:
