Pursuant to 37 C.F.R. § 42.53, please take notice that Petitioners Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. (collectively, “Samsung”), by and through its counsel, shall take the deposition of Brandi Cossairt, Ph.D., commencing October 28, 2021, at 12:00 p.m. EDT, and continuing until completed remotely via videoconference. The deposition will be conducted before an officer authorized by law to administer oaths.
